## CWB Onyx Global Equity Fund – Series A

March 9, 2026

This document contains key information you should know about the CWB Onyx Global Equity Fund, a mutual fund managed by CWB Wealth Management Ltd. **Before you invest in any mutual fund, consider how the fund would work with your other investments and your tolerance for risk.**

Series A units of the fund are no longer available for purchase. After the close of business on or about March 31, 2026, Series A units of the fund will be terminated. At that time, the outstanding Series A units will be redeemed at their net asset value and the redemption proceeds will be paid to Series A unitholders. On or about June 15, 2026, and subject to regulatory approval, the fund will cease to be a reporting issuer. On or about June 15, 2026, National Bank Trust Inc. will replace CWB Wealth Management Ltd. as investment fund manager of the fund.

### What does the fund invest in?

The fund invests primarily in a diversified portfolio of United States and international equity securities, and securities of real estate investment trusts ("REITs") and similar investment vehicles to provide investors with long-term capital appreciation. The fund will generally invest its assets to achieve a target asset allocation of approximately 98% in equity securities and securities of REITs and similar investment vehicles and 2% in fixed income securities.

## How risky is it?

The value of the fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility". In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## Risk rating

CWB Wealth Management Ltd. has rated the volatility of this fund as **medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

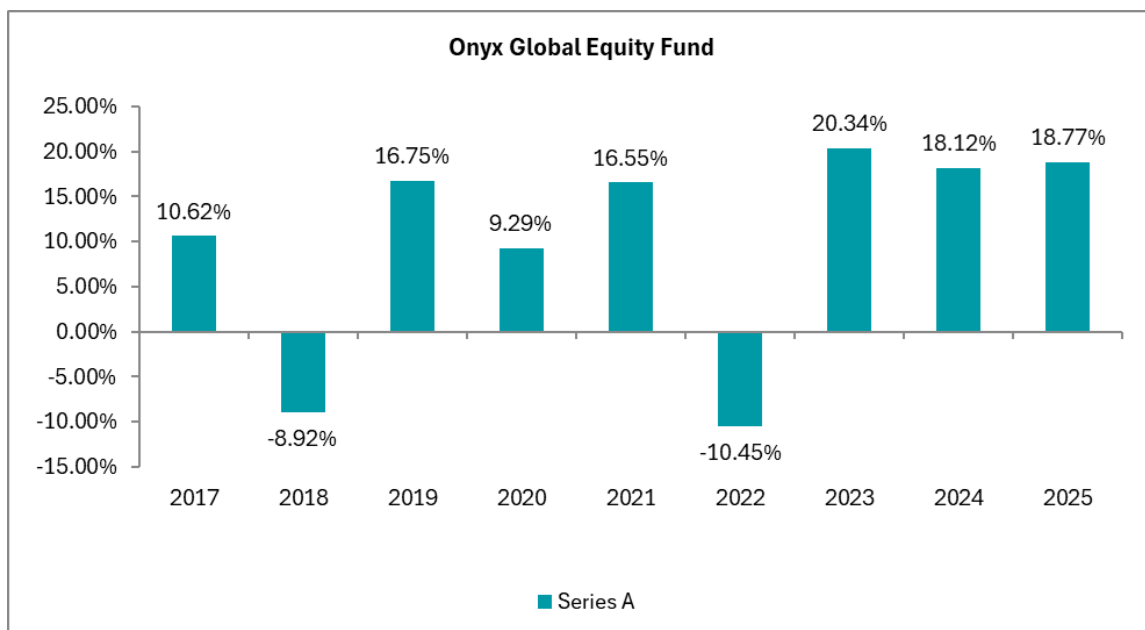
Like most mutual funds, this fund does not have any guarantees. You may not get back the money you invest.

## How has the fund performed?

This section tells you how Series A units of the fund have performed in the past nine (9) completed calendar years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

## Year-by-year returns

This chart shows how series A units of the fund performed in the past nine (9) completed calendar years. The fund dropped in value in two (2) of the nine (9) previous years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



## Best and worst 3-month returns

This table shows the best and worst returns for the Series A units of the fund in a 3-month period over the past nine (9) completed calendar years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

## Average return

As of January 31, 2026, if you had invested \$1,000 in the fund on February 2, 2016, your investment would now be worth \$2,891.55. This equates to an annual compound return of the fund of 11.21%.

## Who is the fund for?

The fund may be suitable for investors who:

- ✓ have a long-term investment time horizon
- ✓ are looking for long-term capital appreciation
- ✓ are willing to accept volatility in the value of their investment and medium investment risk
- ✓ want a low maintenance investment vehicle
- ✓ wish to diversify their portfolio by investment manager and investment style



Don't buy this fund if you need a steady source of income from your investment, have a short-term investment time horizon or are unwilling to accept moderate fluctuations in fund value.

## A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account. Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series A units of the fund. The fees and expenses — including any commissions — can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

Series A units of the fund are not available for purchase and will be terminated on or about March 31, 2026.

### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of June 30, 2025, the fund's expenses were 1.98% of its value. This equals \$19.80 for every \$1,000 invested.

### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide you. CWB Wealth Management Ltd. pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The trailing commission on the Series A units of the fund is 1.00% of the value of your investment each year, or \$10.00 for every \$1,000 invested.

### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

<b>Short-term trading fee</b>	CWB Wealth Management Ltd. has the discretion to charge you up to 2% of the value of your units if you switch or redeem your units within 60 days of buying units of the fund. This fee will be paid to the fund.
