Management Discussion of the Performance of the CWB Onyx Global Equity Fund

Investment Objectives and Strategies

The investment objective of the CWB Onyx Global Equity Fund (the “Fund”) is to achieve long-term capital appreciation by investing in a diversified portfolio of publicly traded U.S. and international equity securities.

We target an allocation of 98% in U.S. and international equity securities, real estate investment trusts and similar investment vehicles. We target an allocation of 2% in Canadian, U.S. and international fixed income securities, including cash and short-term investments, under normal market conditions. The Fund can hold up to 100% of its assets in foreign securities, and the Fund’s holdings in foreign currencies may be actively managed.

Risks

No changes to the Fund affecting the Fund’s overall level of risk were made during the 12-month period ended December 31, 2025 (the “Period”). The risks of investing in the Fund and the suitability of the Fund for investors remain as discussed in the Fund’s most recent simplified prospectus or any amendments or fund facts.

Results of Operations

Over the Period, the Fund’s net assets decreased by \$6,415,581 to \$122,833,467. This reflects an increase of \$25,185,587 from investment performance, distributions to unitholders of \$3,195,274, and net withdrawals of \$28,405,894.

Series A units of the Fund returned 18.77% over the Period versus the Fund’s internal benchmark (the “Fund Benchmark”), a combination of the S&P 500 Index TR \$CAD and the MSCI All Country World Index (ACWI) ex-USA TR \$CAD, which returned 19.92% over the Period. The Fund’s general market index benchmarks, the S&P 500 TR Index \$CAD and the MSCI ACWI ex-USA TR \$CAD (the “Broad-Based Benchmarks”), returned 11.94% and 16.62%, respectively, over the Period. Unlike the Fund Benchmark and the Broad-Based Benchmarks, the Fund’s return is calculated after the deduction of fees and expenses. Returns for individual Series O unitholders of the Fund may vary, largely due to differences in fees and expenses.

Equity markets performed strongly in 2025, driven by slowing inflation, reduced interest rates, and robust corporate earnings. International equities surpassed U.S. markets for the first time in several years.

President Trump began his second term in January and enacted global tariffs on April 2 (“Liberation Day”), causing a brief market correction. Tariffs were adjusted and many nations negotiated new agreements, though U.S. policy uncertainty remains.

Communication services, information technology, and materials outperformed relative to the fund’s benchmark, while industrials, health care, and energy lagged. Key positive contributors included Fabrinet, Antofagasta, and Heidelberg Materials; Worldline, UnitedHealth Group, and Prada detracted.

Recent Developments

Global economic growth is expected in 2025, aided by artificial intelligence and government stimulus, but ongoing ambiguity around U.S. tariff policies could impact global expansion.

Acquisition of Canadian Western Bank by National Bank of Canada and Related Fund Changes

On February 3, 2025, National Bank of Canada completed its acquisition of Canadian Western Bank resulting in a change in control of CWB WM. At that time CWB WM became a wholly owned subsidiary of National Bank of Canada. CWB WM has announced certain planned changes to the Fund as part of the integration of CWB WM's products and services with those of National Bank of Canada and its affiliates. These changes are described below.

i. Termination of Series A

After the close of business on or about March 31, 2026, Series A units of the Fund will be terminated. At that time, units will be redeemed at their net asset value and proceeds distributed to unitholders.

ii. Application to Cease to be a Reporting Issuer

On March 9, 2026, CWB WM filed an application with the relevant securities regulators for an order that the Fund cease to be a reporting issuer. If the order is received, the Fund will not be a reporting issuer in any jurisdiction of Canada, and Series O units of the Fund will only be offered to investors in reliance on available exemptions from the prospectus requirements under applicable securities laws. CWB WM requested to receive the order on or before June 15, 2026. However, there can be no assurance that the order will be granted on or before June 15, 2026, or at all.

iii. Change of Trustee

CWB WM anticipates that effective on or about June 15, 2026, CWB WM will resign as trustee of the Fund and Natcan Trust Company will be appointed to act as successor trustee of the Fund. Natcan Trust Company is a wholly owned subsidiary of National Bank of Canada and is an affiliate of CWB WM.

iv. Change of Manager

CWB WM anticipates that effective on or about June 15, 2026, CWB WM will resign as investment fund manager of the Fund and National Bank Trust Inc. will be appointed to act as successor investment fund manager of the Fund. National Bank Trust Inc. is a wholly owned subsidiary of National Bank of Canada and is an affiliate of CWB WM.

Related Party Transactions

CWB WM is the trustee and manager of the Fund. The Fund pays CWB WM a management fee as compensation for its services. Refer to the section titled 'Management Fees' for a summary of fees paid to CWB WM. On October 10, 2025, National Bank Financial Inc. ("NBF") became the portfolio advisor of the Fund. NBF is a wholly owned subsidiary of the National Bank of Canada and an affiliate of CWB WM.

The CWB Onyx Managed Solution funds, comprised of the CWB Onyx Conservative Solution, the CWB Onyx Balanced Solution and the CWB Onyx Growth Solution, invests in Series O units of the Fund. As of December 31, 2025, 0.26% of the Series O units of the Fund are held by the CWB Onyx Conservative Solution, 7.06% of the Series O units of the Fund are held by the CWB Onyx Balanced Solution, and 6.31% of the Series O units of the Fund are held by the CWB Onyx Growth Solution.

During the Period, CWB WM was party to a participating dealer agreement (the "Dealer Agreement") with Canadian Western Financial Ltd. ("CWF"), which was a subsidiary of CWB WM. Pursuant to the Dealer Agreement,

CWB WM paid CWF a monthly trailing commission equal to 1/12th of 1.00% of the net asset value attributable to units of the Fund held by CWF clients. This trailing commission will be paid directly by CWB WM and will not increase the management fee paid to CWB WM by the Fund. Effective November 24, 2025, National Bank Savings and Investments Inc. (“NBSI”) acquired the business of the CWF and assumed the Dealer Agreement. NBSI is an affiliate of CWB WM.

³ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

⁴ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all the securities in its portfolio once in the course of the year. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The annual management fees and a breakdown of the services received in consideration of the management fees, as a percentage of the management fees, for each series are as follows:

During the Period, the Fund's management fees were used by CWB WM to pay for the cost of managing the investment portfolio, providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sales of investment portfolio, providing other services, and compensating CWB WM for acting as trustee of the Fund. CWB WM also used the management fee to fund trailing commissions and any other compensation to CWF whose clients invest in the Fund.

The Series O management fee is negotiated and paid directly by each investor and will not exceed the Series A management fee.

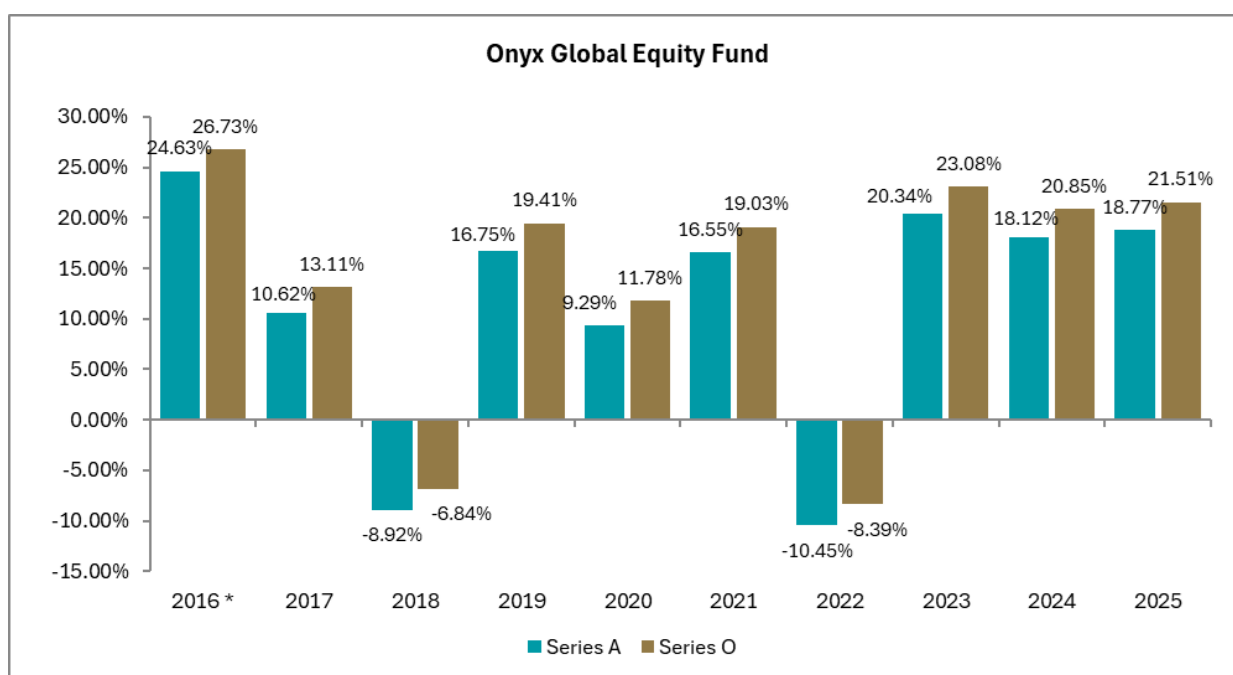
Past Performance
